2.0 Matters Arising

4.0 Clerk's Updates

The Clerk expanded on the requirements for data protection and the need to engage a Data Protection Officer. Cllr Fenney raised the possibility of a DPO who would manage the data protection for a number of parish councils. The Clerk will speak to ERNLLCA regarding the date a DPO should be in post.

5.0 Highways

- 5.1 Cllr Briggs was asked for an update on the proposed new car parking areas in Keadby and reported that legal requirements are delaying progress.
- 5.2 Cllr Briggs was asked for an update on the provision of the site of the old library and said this matter is still ongoing.
- 5.3 It was noted that there are a number of pot holes on Althorpe Main Street, including one right outside the Memorial Hall. The Clerk will report these to North Lincolnshire Council. Cllr Briggs stated that such works will be carried out on a priority basis but that reporting should continue.

7.0 Grass Cutting

The quotations for grass cutting were discussed and it was noted that North Lincolnshire Council have increased their 2017 price by 62.5%. Cllr Pearson proposed that BAK be awarded the contract for grass cutting; seconded by Cllr Buckley.

It was **resolved** that BAK be awarded the 2018 grass cutting contract for Keady and Althorpe

8.0 Parish Paths Partnership

The Clerk informed Councillors that there are two footpaths that would require cutting as part of the Parish Paths Partnership, the cost of the cuts will be paid for by North Lincolnshire Council. The Clerk will visit the locations with Cllr Buckley.

9.0 Issues on Woodgarr Avenue

Concerns have been raised about the vibration generated by large vehicles, often travelling at speed, on Woodgarr Avenue, Keadby. The vibrations are very noticeable and it is thought that they may be causing damage to some properties. Cllr Briggs said that any damage to property would be covered under the residents' buildings insurance but that he would raise the matter internally and that people should raise their complaint, in writing, to North Lincolnshire Council.

10.0 Broadband Althorpe/Derrythorpe

Cllr Stones raised the issue of poor broadband in Althorpe and Derrythorpe and said that, in a newsletter from Andrew Percy MP, it was noted that Althorpe and Derrythorpe would not be 'upgraded' but that a Wi-Fi alternative would be offered. Cllr Stones went on to say that Quickline, who were providing the Wi-Fi solution were 'pulling out' and asked what the solution would be. Cllr Briggs said that he would look into the situation.

11.0 Finances and Payments

Cllr Buckley Proposed that the cheques detailed be approved; Seconded by Cllr Fenney, All in Favour. It was **resolved** that all cheques be Approved.
